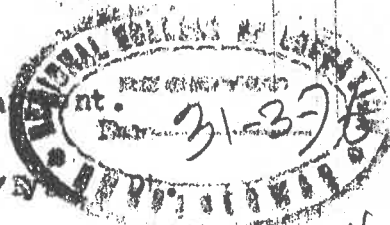

Sir,

I am directed to convey the sanction of Government to an expenditure of Rs. 62,454.20 (Rupees sixty two thousand and four hundred and fifty four and paise twenty) only during the current financial year, 1975-76 for payment of compensation to the private parties in connection with acquisition of land for the Regional College of Education at Bhubaneswar.

The amount should be drawn and placed at the disposal of the Collector, Puri immediately.

The charge is debitable to "Demand No. 10-277-Education, University and other Higher Education (b)-Government College-Office Expenses (Voted)" in the Budget Estimate for 1975-76 the provision under which has been augmented by means of re-appropriation sanctioned separately in Memo No. 13625 Eys., Dt. 27-3-76.

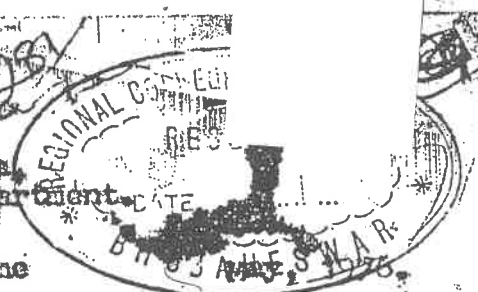

The undersigned is directed to enclose a draft & declaration (in the prescribed form) of 4.10.45 dec. acres of land in Village Bomikhan required by the Education & Youth Services Department for the above noted project which has been administratively approved and to request that the Revenue Deptt. will be so good as to publish the declaration in Orissa Gazette and issue early instructions for the acquisition and transfer of the land to the Principal, Regional College of Education.

2. The enclosed estimate for Rs. 1,20,117.50 towards the cost of the land is sanctioned and placed at the disposal of Collector, Puri by the D.P.I., Orissa vide the Bank draft bearing No. 225804 dt. 28.5.66 and No. ID 750560 dt. 13.4.76.

4. Necessary cost of estt. and contingencies etc., have been calculated in the estimate.

5. Funds for this purpose are available during the current financial year and have been deposited with the Collector.

* On confirmation of the proceedings, the Collector should under rule 145, Chapter XIII of the Bihar and Orissa Land Acquisition Manual 1928, forward a certified copy of the Engineer's plan direct to the Executive Engineer to whom he shall also intimate the cost of acquisition.

The draft declaration under section 6 and estimate have been countersigned by the Revenue Divisional Commissioner.

* Notification under section 4 of Act I of 1894 bearing Revenue Deptt. No. 53671-R. dt. 16.9.63 has been published in the Gazette Extraordinary and that the draft declaration has been prepared strictly in accordance with the Notification under section 4.
